Maxine graduated from Carmen High School and attended business school in Wichita. On January 2, 1942, she was united in marriage to Russell G. Duel in Sawyer, Kansas. They lived in the Carmen area all of their lives where they engaged in farming, dairy, and owned the Aline Locker Plant.
